Camden General Cemetery Clean Up

Camden General Cemetery is an important place for families to reflect, remember, pay tribute and honour their loved ones.

Recently, there has been an increase in the number unauthorised sentimental memorial objects, unapproved adornments and tributes, in addition to unauthorised structures and monuments placed on some of the burial sites.

These items include, but are not limited to:

- Any item consisting of glass, porcelain, brick, cement, wood and metal;
- Chairs, bench seats, barbecues, cooking amenities and umbrellas;
- Unsecured, unapproved, dangerous items, including water-holding vessels and wind chimes; and
- Tributes, memorial and sentimental items such as wreaths, baskets, toys, souvenirs, flags, clothing and all other decorative and loose items.

As noted in Section 2 of the Camden General Cemetery Rules and Conditions for Burials (copy attached), Council holds the right to remove any unapproved items from interment sites. If you would like to read these conditions in more detail, please see these sections outlined below:

2. Council May Remove Objects

- 2.1 Objects which are fragile, likely to cause a risk to health or safety must not be placed on or near a Burial Place.
- 2.2 Council may remove objects placed on or near Burial Places including flower holders, pictures, adornments, plants, which have become dilapidated, unsightly, dangerous or detract from the operation, use, function or amenity of the Cemetery.

To ensure Camden Cemetery remains safe and presentable, please attend the cemetery to remove any items you wish to keep from your loved one's burial sites, that do not meet the Camden General Cemetery Rules and Conditions for Burials 2023, no later than Sunday 29 October 2023.

If families are unable to remove memorial and tribute items during the notification period, any memorial/tribute items that remain in the Cemetery after Sunday 29 October 2023 will be removed by Council as part of this project and will be stored. Items will be made available for collection by appointment.

Families are encouraged to use the bins provided throughout the cemetery to dispose of any items they do not wish to keep. Any larger items can be placed near the bin stands throughout the Cemetery for removal.

We thank you for your understanding and your assistance in helping keep Camden Cemetery safe and presentable for everyone who visits.
