How to enter:

2. Entry must include a guess of the total number of individual items in the Santa Stocking.
3. Multiple entries will not be accepted.
4. Understand, agree and accept all Terms and Conditions detailed here and on the entry form.

Eligibility:

All ages are eligible to enter

Entrants must be in attendance at the Camden Christmas Festival and/or Oran Park Christmas Concert event/s.

Camden Council employees, volunteers, contractors, consultants, Committee members, their families and household members are ineligible to enter.

Format:

Entries must be submitted on the manual entry form at the Camden Council stall at the event.

Entries submitted in any other form will not be accepted.

Number of entries:
